- >> Tax Withholding
  - All required Federal and FICA tax changes effective January 1, 2021, and the FICA Wage Base Limit change to \$142,800, as well as the State tax changes we received by December 18, 2020 are included. To view the 2021 State tax changes, check our website for current information.

#### » Setup

- Employees Added new coverage Offer codes 1L 1S for HRAs (Health Reimbursement Arrangement) for 2020 Affordable Care Act reporting.
- Payroll Details > Employers Added a new Self-Insured Origin Code G Individual Coverage HRA (Health Reimbursement Arrangement) for 2020 Affordable Care Act reporting.

### >> Reports

- Federal & State Payroll Forms & Reports Updated CenterPoint to send appropriate COVID paid wages to 2020 tax forms.
- Payroll Data Reports > COVID Reports > PPP Loan Forgiveness Report for 8 and 24 Week Cover Periods – Added reports that include employee payroll costs to assist in filling out the SBA Payroll Protection Program Loan Forgiveness Application if you are applying for loan forgiveness using an 8 or 24 week cover period. Qualified health insurance costs must be selected in Setup > Payroll Details > COVID-19 Reporting Items on the right side of the screen to display on the reports.

Setup > Names > Names - When the Name Format is set to Individual, the tab stops are now set in a logical data entry order.

- Backup Database When backups are performed the same day and saved to the same location, the Save To File Name will now be incremented to ensure that it is unique and does not already exist in the Save To location.
- Administration > Lock Periods Added the ability to optionally lock periods for a selected company rather than for all companies in a database.

- List tab Added the ability to activate/deactivate multiple employees for an employer for specific companies/funds.
- » Earnings tab
  - When a new earning is added to an employee, the base rate for the earning type will be the default rate for the earning, if no rate for the earning is set in Setup > Payroll Details > Employers.
  - Added an Update Last Raise Date checkbox to the Earnings Update screen. When a new Base Hourly Rate is updated with a new effective date and the new checkbox is selected, the Last Raise Date on the Employment tab will be updated with the new effective date.

### >> Payroll Details > Earnings

- List tab- Added a new Add to Employees right-click option that allows earnings to be added to selected employees.
- >> New Earnings can now be added to employees at the time the earning is created.
- Forms Designer > Payroll Check Stub Forms Designer Added a new available Pay Advance Balance field.

#### >> Companies/Funds

- Detail tab > Tax Report > Repost Balances Improved the efficiency of reposting account balances.
- » Companies Optimized the efficiency of displaying and saving a company.
- Accounts > Accounts
  - Detail tab If the Processing Bank Routing Number is not entered on the ACH/Direct Deposit tab, the Bank Routing Number from the Detail tab will be used in the direct deposit file.

ACH/Direct Deposit tab - Added the following changes to the Advanced Settings: Replaced all the date fields with a drop-down list containing YYMMDD (default), DDMMYY, and MMDDYY, replaced the Settlement Date (Julian) field with a free-entry numeric field containing blank (default) or a value of 0 to 365, and replaced the Discretionary Data field with a 2-byte alpha-numeric field which is blank by default.

#### >> Processes

- ACH Files Added ACH processing functionality which allows you to deposit electronic payments directly into your vendor's bank account from CenterPoint Payroll.
- Direct Deposit > Create Direct Deposit Files The last used File Path location will now be recalled when a specific output location is not set (blank) in the Save to Folder box in Setup > Accounts > Accounts > ACH/Direct Deposit tab.
- Pay Employees Added a Tax Liability prepayment report that reports on unposted pay run information.

#### » Reports

- Improved the speed of printing reports when printed over a network or from the Red Wing Software Cloud Service.
- Batch Reports Added a new Include Report List Page report selection filter that will allow you to include a list of the reports generated in the batch as the last report in the batch.
- Favorites or Database Favorites When batch reports are exported to a PDF or Microsoft Excel, reports that do not generate data will be excluded from the batch.

#### >> Federal & State Payroll Forms & Reports

- Added a Date Range option to any Federal or State report that requires a Time Period selection. The Date Range allows you to select standard CenterPoint predefined periods, for example, Today, This Quarter, This Year, etc.
- Added support for reporting non-employee compensation on the new 1099-NEC form. Note: The form is available in CenterPoint now, but will not be available to file in Aatrix until the 4th Quarter update is released the week of December 21, 2020.

- Employee Leave Added optional available Accrual Rate and Frequency columns to the report.
- Employee Deductions & Benefits List Added a new Show Only Current Employer Rates report selection filter that will display every Employer rate (by Effective Date) for a deduction/benefit. Also renamed the Show only current rates report selection filter to Show Only Employee Rates.
- Workers' Compensation Classes > Workers' Compensation Classes Added a Show Only Current Rates optional available filter to the report.

#### » Payroll Tax Data Reports

- Federal Tax Reports > Federal Unemployment Tax by Employee Added an optional available Exempt Pay column to the report which is calculated as Gross Wages - (Taxable Wages + Wages Over Limit).
- State & Local Tax Reports > State Unemployment Tax by Employee The report will now include both Employer and Employee Wage Limit and Rate information.

Leave > Employee Leave Balances - Added the following optional available columns to the report: Hire Date, Eligibility Date, Termination Date, and Termination Reason.

- Employee Deductions, Benefits, Taxes Overridden Added a report that displays deductions, benefits, and taxes that have been overridden after they have been calculated in a pay run.
- COVID-19 Reports > PPP Loan Forgiveness Payroll Cost Details and PPP Loan Forgiveness - Payroll Costs - The Employer Retirement Cost column will now include taxable and non-taxable deduction/benefit types.

#### » Processes

- When an hourly rate on an employee is changed and a new pay run is created by copying from a previous pay run and earnings are kept, the total amount will now be based on the new rate instead of the previous rate of pay.
- When using inter-fund payroll distributions and processing a payroll that includes only earnings subject to a tax that an included taxable benefit is subject to, the payroll can now be posted without error.
- Pay Employees > Direct Deposit file creation or Processes > Direct Deposit > Create Direct Deposit Files – When a direct deposit file is created using advanced direct deposit settings, the default date formats will render based on the prior settings without resaving the direct deposit settings.
- Post & Print Under very specific circumstances that displayed an error, pay runs can now be posted and printed successfully.
- >> Timesheets > Time Import
  - When the import file contains multiple expense accounts (up to three), Expense Account 1 - 3 will now be set to the proper values from the import file.
  - >> **Time Import Files** Time can now be imported successfully when a lookup field in the import file contains a name with a single quotation in the name.

- Employees/Names > Attachments Scanned attachments can now be viewed from the repository prior to saving the setup screen.
- File > Security > Security Policies Removed the Allow Publish Pay Advices security policy under Setup > Employees which was incorrectly restricting access to Employee maintenance.

  - State & Local Tax Reports > State & Local Tax Withheld by Employee The Taxable Wages column will now apply an associated Wage Limit.
  - Federal Tax Reports > W-2Summary The Taxable Wages column will now apply an associated Wage Limit.
- Batch Reports When exporting a batch of reports to Microsoft Excel, reports with titles longer than 30 characters will no longer be excluded.

### **CenterPoint Time Clock**

Added the ability for employees to report tips earned during their shift when they clock out so taxes can be calculated without manually collecting and entering tip amounts.

When the Type of import is set to Employees, the following columns have been added which will allow you to import employee W-4 information: IsNew2020W4OnFile, W4Step2MultipleJobs,

FedDependentCreditAmount, FedOtherIncome, FedDeductions, FedIsNonResidentAlien, FedUseAlternateFlatTax, FedFlatTaxPercent, and StateFilingStatus.

- When the Type of import is set to Employees, direct deposit information (rows) can now be added as well as updated from a file through the update.
- Show Command Line When the import type is Names, the type of import will now be included on the command line.
- » Removed the Can Be Empty column.

If you did not follow the CenterPoint COVID paid leave setup process, the COVID-19 information will need to be manually entered on the 941 form in the software. For more information, see the COVID-19 Leave Setup & Reporting document.
  - Reports > Payroll Data Reports > COVID-19 Reports > PPP Loan Forgiveness Payroll Costs – Added a new report that includes employee payroll costs to assist in filling out the SBA Payroll Protection Program Loan Forgiveness Application. In order to see your qualified health insurance costs on this report you must identify those costs by going to Setup > Payroll Details > COVID-19 Reporting Items and select the qualified health insurance cost items in the list on the right side of the screen.

#### >> Tax Withholding

- >>> Idaho 2020 interim state withholding changes effective 7/1/2020.
- >> New Jersey Family Leave and TDI 2020 Taxable Wage Base change to \$35,300 effective 1/1/2020.
- Employer and employee wage limits will now be applied correctly when a tax uses different employer and employee wage limits. This primarily affects the New Jersey Temporary Disability Insurance tax and the NJ927/WR30 report.

#### » File

- Exports Added a generic retirement export available for purchase that allows you to make custom modifications to retirement exports.
- Security > Security Policies Added a new Allow Payroll Search security policy under Transaction Search that replaces the Transaction Search (No Payroll) security policy under Processes. When the Allow Payroll Search security policy is set to No, transactions where the Entry Screen is Pay Employees will be excluded. Users who previously only had access to Transaction Search (No Payroll) will automatically have the security policy set to No.

- Time Sheets and Salary Time Allocation The calculation of hours between Start and Stop Times will now be rounded based on the Hours decimal places set in File > Preferences > General.
- Work Group Time Sheets > Employee button > Filters button Added the following filters to the Select a filter list: Abbreviation, First Name, Last Name, Department, and Employment Status
- Processes > Pay Employees > Select Employees tab Added the ability to filter the Select Employees tab by Pay Period.
- » Transaction Search
  - Filters tab > More Items Changed the name of the Transaction Amount filter to Transaction Journal Amount and added a new Total Bank Amount filter.
  - » Removed the Transaction Search (No Payroll) menu item.

#### >> Employees

- Documents can now be attached to employee records by scanning, dragging and dropping existing files from your computer, or by selecting an existing file from your computer.
- Publish Pay Advices tab -When you click the Unregister button, you will now be asked if you are sure you want to unregister the employee and you will receive a message if the process is successful or if it fails.
- Deductions & Benefits tab Added a new Alternate Name box that can be used to supply information specific to the employee on the check stub when vendor checks are printed. For example, for a child support deduction, it may be necessary to supply a Case Number specific to an employee garnishment.

#### >> Accounts > Accounts

- Direct Deposit tab Renamed the Social Security Number box to Employee Identifier and added an Employee Abbreviation option to the drop-down list that when selected will fill the Employee Identifier field in the Direct Deposit file with the Abbreviation from the Setup > Employees screen.
- » When an existing account is edited, the Account Type will no longer be able to be changed.
- Forms Designer > Check Stub Form Designer Added the following new available fields from the 2020 W-4: Federal Dependent Credit Amount, Federal Other Income, Federal Deductions, and Federal Extra Withholding.
- >> General > Canadian Postal Codes Removed the Canadian Postal Codes menu item.
- » Payroll Details
  - » Time Clock Settings
    - Options tab Added a new Restrict Clock In/Out to GPS Locations check box that can be used if your employees will only be able to clock in/out through the CenterPoint Time Clock website and app if their GPS coordinates place them within the determined radius of one of the defined locations set on the Setup > Time Clock Settings > Locations tab.
    - Locations tab Added a new Locations tab that is used if you are restricting clock in/out entries within the radius of specific GPS latitude and longitude coordinates. The radius can be set to Meters, Kilometers, Miles, or Yards.
  - » Local Taxes Updated the list of tax forms items.
  - Start-up Pay Start up pay runs are no longer required to be dated within the open periods in the database.
  - >> Time Import Definition > Definition tab Changed the WComp State label to WComp.

#### » Reports

- Database Favorites tab Added the ability to Export/Import all database favorites into/from one DatabaseFavorites.cpfavs file. When database favorites are imported, all existing database favorites are overwritten.
- Batch Reports When reports are printed from a batch folder for a company with a Fiscal Year YTD date range filter and the batch date is changed to a prior calendar year, the period dates for the reports will now display correctly.
- » Added a Next Week option to the Date Range report selection filters.
- Payroll Setup Lists > Employees > Employees Tax List Added a new Tax Active available column and report selection filter to the report.
- » Payroll Data Reports
  - Earnings > Earnings Detail Renamed the Rate column to Calculated Rate and added a new Pay Run Rate column to the report.
  - Payroll Register > Certified Payroll Journal Added a new report that reports payroll by project and employee. Earnings are reported by workers' compensation class and work date. Benefits, deductions, and employee taxes are reported by project. To use this report, earnings should be entered on time sheets or imported to time sheets in CenterPoint Payroll to keep track of work dates. Projects must be included on time sheet entries and not account distributions.

Dashboards > Add/Remove Tiles > Delete - Added the ability to delete a custom dashboard tile and also remove it from the list of dashboard tiles on the Add/Remove Tiles screen.

    - Forms Designer > Payroll Check Stub Forms Designer When a check stub is set up to summarize by work date and the stub overflows to a separate sheet, the overflow sheet will now include work date detail.

- Reports > Payroll Tax Data Reports > Tax Liability > Tax Liability The report will now only include posted pay runs.
- Federal & State Payroll Forms & Reports > State Tax Forms The OR OQ/132 report will no longer include hours for the WBF tax if all employees are exempt from the tax

### **CenterPoint Time Clock**

- Added the ability for employees who work in multiple departments to have their time managed by the appropriate department supervisor.
- Added a new Employee > Employee Status screen that displays all employees a supervisor is responsible for and their current status/detail: In, Out, or on Leave. From this screen, a supervisor can perform the following functions for a group of or individual employees: clock in/out, add time, or display a map that shows the GPS clock in/out location.
- » Added the ability to limit employee clock in/out to specific GPS coordinates.
