- Processes > Revenues > Billing Statements Added an optional available Receivable Account report selection filter that allows you to filter your billing statements by AR account.
- Property > Reports > Transaction Reports > Sales & Accounts Receivable > Open Invoices Added an optional available Accounts Receivable Account report selection filter that allows you to filter the report by AR account.

 - Processes > ACH Notices > Create Prenote Corrected an issue with creating ACH prenote files for vendor payments.
 - CenterPoint Data Importer When receipts are imported, the default billing address will now be imported from the import file.

Permits

User Defined Tax Reports

- 1099-MISC Added a new 1099-MISC form for 2021 that includes row 10 "11 Fish Purchases for resale". If your fund is required to report Fish Purchases for Resale, the existing 1099-MISC form should be deleted and the new form should be imported.
- 3099-DIV Added a new 1099-DIV form for 2021 that includes new boxes for 2021: 2e Section 897 ordinary dividends and 2f Section 897 capital gain and box changes not included from years prior to 2021. The old form will be renamed 1099-DIV (OLD).

- AP Open Invoices by Project Added a new report that lists Accounts Payable open invoice amounts, payments, and balance due by project.
- Project Summary Added a new report that provides summary updates on project revenue, expenses, and profit.
- Financial Statements > Income Statements and Cash Flow reports Added Account and Account Category filters to income statements and cash flow reports. By default, the Report Options selected will display the filters selected at the end of the reports to help customers identify how the report was printed.

Transaction Reports

- Transaction Journals > Transaction Journal and General Journal Updated the Date Created column: Changed name from Create Time, added ability to change date format, and added a report selection filter for Date created.
- Missing Checks Added an optional Audit Trail Comment column that will display the Description entered when a check is voided.
- Fixed Assets > Fixed Asset Activity The report will now include fixed assets with only a beginning balance.

- Adjustments toolbar button Added "Adjustments" text that displays when you mouseover or hover-over the toolbar button.
- Budget Properties > Security tab When database security is set up with user groups, the user group(s) will now be automatically selected under Grant Access to User Groups.

Accounts > Accounts - When the Standard Entry Class on the ACH/Payments tab for a vendor is set to CTX, the ACH file will now be formatted correctly.

- Periodic > Apply Distributions Distributions associated with WIP asset accounts will now apply according to the details in Setup > Accounts > Distributions without first switching the distribution.

- Batch Transactions When a transaction is included in a batch that was entered with multiple lines for different companies/funds to the same bank account, only one row per transaction will now be displayed.

- Open When a database does not include accounts for the Other Expense account type in a database, a budget can now be opened successfully without a Formula incorrect error.
- When creating budgets that use multi-segmented accounts, the budget can now be created without error.

- **Export** When exporting a report to Microsoft[®] Excel that includes hidden groups, the report will now include header text of the first visible group header and export successfully.
- Financial Statements > Statement of Cash Flows by Month When the report is filtered by fund and a row is drilled-down, the Cash Flow Detail report will now display filtered by fund.

Transaction Reports

Payments > Payments Journal - When entering transactions that have a debit/credit to the same general ledger account (wash), the reported cash Amount will now be accurate.

- Payments & Accounts Payable Accounts Payable Activity report If a term discount is taken when an Accounts Payable invoice is paid, the Account Balance column will now be decreased by the term discount amount.
- Sales & Accounts Receivable Daily Sales The report will no longer display entries from the Receipts screen.

Advanced A/R Module

Processes > Item Price Lookup - Added a new screen that allows you to enter a quantity used to calculate a price based on the price level, location, quantity, and unit of measure. The information available on the screen includes Sales Price, Quantity on Hand, Quantity Assigned (on an unfilled sales order), Quantity Available, Quantity on Order (on a purchase order but not yet received), and Unit of Measure.

- Added a Base Price + Additional Quantities pricing method that builds the price up across multiple quantity breaks with an initial minimum price specified in the first break.
- Added a Cumulative Price pricing method that builds the price up across multiple quantity breaks.
- The Pricing tab will now be active for non-inventory type items without the additional Inventory module. This expands the type of pricing to include quantity breaks, cumulative quantity pricing, and base price + additional quantities.

>>> Setup > Customers > General tab > Sale Tax - When changing the Sales Tax on an existing customer, the Sales Tax will now be saved.

Permits Module

The Permits module for CenterPoint Fund Accounting for Municipals allows municipal organizations complete management of their permits, including setup and maintenance, processing, and permit payments.

» Permit Setup

- Easily customize each permit and its process flow, so the processing and payment flows easily.
- A built-in forms designer makes it easy to create permit forms that fit for your municipal.
- Set up each permit with the option to print up to three forms: the permit, invoice and receipt. All three are created and maintained in the permit forms designer.
- Easily create permit transactions which control the fund, accounting, items, sequence, and expiration date. For example, Building Permit, Roofing Permit, Garage Sale Permit, Picnic Permit, Park Use Permit, etc. Once set up, the flow of processing each permit is seamless.
- An optional Properties setup function allows properties to be assigned to Building type permits to report all permits to a particular piece of real estate.
- Each permit payment can be set up to print up to three transactions: the permit, invoice, and receipt.

Permit Processing & Payments

- Easily email permit forms to customers or print them.
- Customers can pay immediately and receive a receipt, or if Accounts Receivable is selected as a payment option, the payment is saved for later payment, perfect in the case a customer needs to go to another department to make a payment.
- Run Permit reports by expiration date, sequence number, fund, account, and active status.
